The Department of Criminology and Criminal Justice invites applications for a Postdoctoral Fellow. This is a fixed term (one year, with the possibility for a renewal for a second year). Applicants should hold a Ph.D. in criminology, sociology, or a related field, though ABDs are encouraged to apply. Preference will be given to applicants who specialize in prosecution/sentencing and racial disparities, have experience working with large administrative datasets, and use data visualization software such as Tableau or Power BI.

The Postdoctoral Fellow will collaborate with faculty on work related to the advancement of effectiveness, fairness, and efficiency in prosecutors’ offices. Occasional travel to jurisdictions both within and outside of Florida will be required. The position will provide opportunities for producing policy-relevant research, grant proposals, and academic publications.
